

# Description of Data in SRC2020.mdb

This SRC.mdb ReadMe file was updated June 2021 to include information about changes to the 2020 Report Card Database (SRC2020) following corrections to 2020 accountability data publicly released December 23, 2020 and 2019 accountability data publicly released February 13, 2020.

The updated SRC2020 and this SRC.mdb ReadMe file reflect corrections made to code that calculated 2019 accountability graduation rates for the English Language Learners subgroup and that suppressed the display of 2019 accountability graduation rate cohort counts. New information is marked with an asterisk \* and highlighted in yellow (\*).

This document describes the data in the tables in the Report Card Database (SRC2020.mdb). These data are those in the New York State Report Card on data.nysed.gov and include statewide, public school district, public school, charter school, county, and need-to-resource capacity (N/RC) levels, as applicable. For a more full understanding of the data within the Report Card Database, please refer to the 2019-20 Report Card Glossary & Guide, available at <https://data-dev.nysed.gov/files/essa/19-20/glossary.pdf>.

The tables included in this download have no indices to economize on file space and download time. You will probably want to create indices on INSTITUTION\_ID and/or ENTITY\_CD and other key fields to improve your local query performance. In some cases, values may be stored as text items of length 255. This is an Access artifact. The content is of much shorter, but varying length, and usually formatted for presentation. If computations are to be performed with these numbers, please use the Val() function in any Access expressions to convert to a numeric data type.

**Due to COVID-19 and resulting changes to New York State testing, accountability, and federal reporting requirements, 2020-21 district and school accountability statuses are the same as those assigned for the 2019-20 school year. For informational purposes, graduation rates for the Secondary Graduation Rate indicator using lagged 2018-19 data are reported. Spring 2020 standardized state assessments, including the June 2020 Regents examinations, were canceled and are, thus, not reported. # General

## ***INSTITUTION\_ID***

The INSTITUTION\_ID is a 12-digit unique identifier for each institution – a code that remains consistent over time, unlike the ENTITY\_CD (BEDS Code) which updates with changes in location or district assignment, for example.

## ***ENTITY\_CD***

The ENTITY\_CD in the following tables is the 12-digit Basic Educational Data System (BEDS) code that uniquely identifies the entity (school, district, etc.). The following information may be useful to researchers who want to select or aggregate data for specific entities.

Digits	Indicate
1–2	County of Location
3–4	City/Town of Location
5–6	School District Number
7–8	District or LEA Type
9–12	Reserved for Building

### ***Need-to-Resource Capacity Categories***

The need-to-resource capacity (N/RC) index, a measure of a district's ability to meet the needs of its students with local resources, is the ratio of the estimated poverty percentage<sup>1</sup> (expressed in standard score form) to the Combined Wealth Ratio<sup>2</sup> (expressed in standard score form). A district with both estimated poverty and Combined Wealth Ratio equal to the State average would have a N/RC index of 1.0. N/RC categories are determined from this index using the definitions in the table below.

Code	Category	Definition
1	High N/RC: New York City	New York City
2	High N/RC: Large City Districts	Buffalo, Rochester, Syracuse, Yonkers
3	High N/RC: Urban-Suburban Districts	All districts at or above the 70 <sup>th</sup> percentile (1.1835) that have: 1) at least 100 students per square mile; or 2) an enrollment greater than 2,500 and more than 50 students per square mile.
4	High N/RC: Rural Districts	All districts at or above the 70 <sup>th</sup> percentile (1.1835) that have: 1) fewer than 50 students per square mile; or 2) fewer than 100 students per square mile and an enrollment of less than 2,500.
5	Average N/RC Districts	All districts between the 20 <sup>th</sup> (0.770) and 70 <sup>th</sup> (1.1835) percentile on the index.
6	Low N/RC Districts	All districts below the 20 <sup>th</sup> percentile (0.770) on the index.
7	Charter Schools	Charter Schools

<sup>1</sup> **Estimated Poverty Percentage:** A weighted average of the 2006–07 and 2007–08 kindergarten through grade 6 free-and reduced- price-lunch percentage and the percentage of children aged 5 to 17 in poverty according to the 2000 Decennial Census. (An average was used to mitigate errors in each measure.) The result is a measure that approximates the percentage of children eligible for free or reduced-price lunches.

<sup>2</sup> **Combined Wealth Ratio:** The ratio of district wealth per pupil to State average wealth per pupil, used in the 2007–08 Governor's proposal.
