They show superior knowledge and skill for each standard for elementary students and are proficient (692 - 800)at some intermediate-level skills in listening, reading and writing. Students show thorough understanding of written and oral text. Students' writing is well organized with minor errors that do not interfere with readability. These students meet the standards and, with continued steady growth, should pass the Regents Level 3 examination. They show knowledge and skill for each standard for elementary students and show some intermediate-level skills in listening, reading and writing. Students show understanding of written and oral text. (645-691) Students' writing is generally focused and organized with minor errors that do not interfere with readability. These students need extra help to meet the standards and pass the Regents examination. They show some Level 2 knowledge and skill for each standard for elementary students, but none of the intermediate-level skills in listening, reading and writing. Students show partial understanding of written and oral text. Students' writing has some focus (603-644)and basic organization and uses simple sentences and vocabulary. Errors sometimes interfere with readability. These students have serious academic deficiencies. They show no evidence of any proficiency in one or more of the elementary standards and incomplete proficiency in all three of the standards. Students show minimal Level 1 (455-602) understanding of written and oral text. Students' writing is brief, general, or uses repetitive statements, and reveals difficulty in organizing thoughts. Errors interfere with readability.

#### Performance of English Language Learners (ELL)

ELL are students for whom English is a second language. Schools teach these students English so they can participate effectively in the academic program. ELL students without sufficient proficiency in English are not required to take the grade 4 ELA test. Their progress in learning English is measured, using standardized tests, and reported.
